7. Any other business:

- New Committee to review current membership list and focus on targeted outreach for areas of the industry currently unrepresented e.g. libraries, smaller publishing houses.
- Committee proposal for a member survey to help identify the current make-up of the membership and therefore what the underrepresented areas are. Proposal for survey to be presented later in the year, to be commissioned externally (£) now that Book Society finances are in better shape.
- Sponsoring dinner places and memberships to be revisited by the Committee now that Book Society finances are in better shape. Potential for commercial sponsorship from e.g. CGI (who have offered). Poor take-up for scheme previously but needs to be simpler and better communicated.
- The Book Society Constitution needs to be reviewed by the Committee with any amendments proposed and agreed at the next AGM e.g. minimum attendance at dinners, election to honorary membership.
- The Book Society needs to define its mission and purpose. Committee to discuss.
- Committee to review criteria for approving nominated members more diverse, younger members vs senior leaders.
- Would it be possible to have a members directory on the website (password protected)?
 Committee to discuss what would be desirable and Jo Dawson to work out implementation with Simon Appleby (Book Society member and Founder of Bookswarm who provide our website support)
- Should we have a Code of Conduct? A useful tool to reassure members and guests that
 events will be both fun and safe. Suggested example
